ACTION REQUESTED:

Selection of one firm and an alternate to provide Residential Substance Abuse Treatment Program, Request for Proposals Y18-1016-KB, from the following firms listed alphabetically:

Specialized Treatment Education and Prevention Services, Inc.
The Transition House

Request authorization for the Procurement Division to negotiate and execute a 3-year contract within a total budget amount of \$327,600. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

This item was evaluated by the Procurement Committee on November 28, 2018. Commissioner Jennifer Thompson was assigned to the Procurement Committee.

PROCUREMENT:

This contract will provide annual evidenced-based treatment and practices for adult inmates that are identified as in need of substance abuse treatment. Additionally, the program will be extended, in a modified form, to include the Orange County Work Release Center.

FUNDING:

Funding will be made available in account number 1660-081-3830-3197.
