RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Group Dental Insurance Plan, Request for Proposals Y18-1102-AH, from the following firms listed alphabetically:

Cigna Health and Life Insurance Company Delta Dental Insurance Company Metropolitan Life Insurance Company

Request authorization for the Procurement Division to negotiate and execute a 3-year contract. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

The proposals were evaluated by the Procurement Committee on August 8, 2018. Commissioner Betsy VanderLey was assigned to the Procurement Committee.

PURPOSE:

The purpose of this contract is to provide dental insurance to employees of Orange County Board of County Commissioners, Comptroller's Office, Clerk of Courts, Property Appraiser, Supervisor of Elections, Tax Collector, Orange County Housing Finance Authority, Central Florida Research Park, South Orange Blossom Trail Development Board, MetroPlan Orlando, and the International Drive Master Transit and Improvement District.

DISCUSSION:

Orange County offers group dental insurance on a voluntary, employee paid basis to all eligible employees and their dependents upon completion of the eligibility waiting period and to all eligible retirees. Group dental insurance is offered through the Section 125 Cafeteria Plan, and eligible employees/retirees are allowed to enroll/terminate group dental insurance during the annual enrollment period.

The estimated annual dental insurance premium will be \$13,359,727.20. Increases in premiums are restricted for the first three years. The premiums for this coverage are paid entirely by employees.

Six proposals were received in response to this Request for Proposals. The proposal received from United Concordia Dental was approved for withdrawal by the Procurement Manager. The proposals received from The Standard Insurance Company and Aetna Life Insurance Company scored too low for Board consideration. Protests were filed by Delta Dental Insurance Company and Metropolitan Life Insurance Company. Protest hearings were conducted and the protest committee unanimously voted to uphold the scores as accepted at the procurement committee meeting held on August 8, 2018. Metropolitan Life Insurance Company appealed the decision of the protest committee.
