SUBJ: **Release and Termination of Temporary License Agreement between City of Orlando and Orange County for Safe Streets Academy Candidate Project**

On March 6, 2018, the Board approved a Temporary License Agreement between the City of Orlando and Orange County for conducting a candidate project along Curry Ford Road as part of the National Complete Streets Coalition's "Safe Streets Academy." The project limits were from S. Bumby Avenue to S. Crystal Lake Drive. The public right-of-way portion of these limits is located within unincorporated Orange County.

The purpose of the candidate project was to perform a pilot study to test temporary transportation safety countermeasures selected from business and community outreach efforts. The project included installation, maintenance, and removal of temporary devices within the County right-of-way for a period of no more than 120 days.

The City of Orlando completed the project on August 14, 2018, and has removed the improvements and restored the County right-of-way.

Staff recommends approval and execution of the Release and Termination of Temporary License Agreement between the City of Orlando and Orange County. This release has been approved as to form by the County Attorney's Office.

RELEASE AND TERMINATION OF TEMPORARY LICENCE AGREEMENT
BETWEEN
CITY OF ORLANDO AND ORANGE COUNTY

This RELEASE AND TERMINATION OF TEMPORARY LICENCE AGREEMENT between **CITY OF ORLANDO** and **ORANGE COUNTY** ("RELEASE") is made and entered into this ____ day of JAN 15 2019, 2018, by and between **ORANGE COUNTY**, a charter county and political subdivision of the State of Florida with a mailing address at P.O. Box 1393, Orlando, FL 32802-1393 ("COUNTY "), and the **CITY OF ORLANDO**, a municipal corporation created by and existing under the laws of the State of Florida whose address is P.O. Box 4990, 400 S. Orange Avenue, Orlando, Florida 32802 (the "CITY") .

WITNESSETH:

WHEREAS, the COUNTY and the CITY entered into a TEMPORARY LICENSE AGREEMENT BETWEEN CITY OF ORLANDO AND ORANGE COUNTY, "AGREEMENT," on March 21, 2018, recorded in the Official Records of Orange County, Florida, Instrument Number 20180163302; and

WHEREAS, pursuant to the terms of the AGREEMENT, CITY conducted a temporary project (the "PROJECT"), as part of the National Complete Streets Coalition's "Safe Streets Academy," along Curry Ford Road between South Bumby Avenue and South Crystal Lake Drive which included installation of improvements within certain COUNTY rights-of-way; and

WHEREAS, the CITY completed the PROJECT on August 14, 2018; and

WHEREAS, Paragraph 8 of the AGREEMENT provides that the parties shall execute a RELEASE of the AGREEMENT upon the CITY's completion of the PROJECT.

NOW THEREFORE, in consideration of the mutual covenants set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the CITY and COUNTY hereby agree as follows:

1. Recitals. The recitals set forth above are true and correct and are incorporated herein by this reference.
2. Termination. CITY and COUNTY hereby terminate the AGREEMENT as of the Effective Date, upon which termination, the parties are relieved of any further obligations thereunder.
3. Recording. Upon execution, this RELEASE shall be recorded in the Official Records of Orange County, Florida.
4. Effective Date. This Release shall become effective on the date of full and complete execution by the parties hereto.
