ACTION REQUESTED:

Approval to award Invitation for Bids Y19-600-TJ, Orange County Convention Center Food Services Renovations Equipment for Food Courts A & B Cafe, to the low responsive and responsible bidder, 7Gens, LLC in the total award amount of \$864,492.

PROCUREMENT:

This contract will provide new kitchen equipment for essential services to serve clients and visitors through the upgrade of Orange County Convention Center cafes and kitchens.

FUNDING:

Funding is available in account number 4430 035 0960-58 6410 and 4430 035 0960-58 4123.

APPROVALS:

The Orange County Convention Center and Business Development Division concur with this recommendation.

REMARKS:

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Clark Food Service Equipment was deemed non-responsive for failure to submit the mandatory revised bid response form.

The recommendation to award is either on an all-or-none basis to the lowest responsive and responsible bidder or to award on a lot-by-lot basis to the lowest responsive and responsible bidder, whichever is in the best interest of the County. The option of awarding lot-by-lot resulted in a cost savings of less than 1%; therefore, it was determined that the best interest of the County is an all-or-none, single award, avoiding the administrative cost of administering multiple contracts. Administration of this contract requires time-sensitive coordination between the County and general contractors installing this equipment. The lowest responsive and responsible bidder, 7Gens, LLC, meets all of the requirements of this solicitation. Therefore, recommendation for award is made to 7Gens, LLC.
