### **ACTION REQUESTED:**

Approval to award Invitation for Bids Y19-713-RM, Summerlake Subdivision Drainage Improvements Area 2, to the low responsive and responsible bidder, Stage Door II, Inc. in the total contract award amount of \$186,734.

#### PROCUREMENT:

Work under this contract consists of installation of a series of underdrains below the pavement which involves reconstruction of a section of Bahama Swallow Boulevard. The project is located in District 1.

#### **FUNDING:**

Funding is available in account number 1004 072 3010 6330.

#### APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

### **REMARKS**:

Three bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Although the bid submitted by Stage Door II, Inc. is approximately 63% lower than the second low bidder, staff evaluated the bids, and it is considered reasonable based on the engineer's estimate. References provided were satisfactory for this type of work and Stage Door II, Inc. has been determined to be responsible. Therefore, award is recommended to Stage Door II, Inc.

The Business Development Division evaluated the 3 bids submitted for this project and found that the apparent low bidder Stage Door II, Inc. did not achieve good faith effort documentation and reported 9.91% MWBE participation in their bid. Please note the following certified MWBE participation:

Wbe-wf	The Pipe Nipple & Supply Company, Inc.	\$10,500
Mbe-am	Central Hauling & Excavating, Inc.	\$8,000
Total MWBI	E Participation	\$18,500.00 (9.91%)

The second low bid submitted by RMS Constructors Group, LLC met the MWBE participation goal and reported 25.53% MWBE participation in their bid.

The third low bid submitted by DB Civil Construction, LLC did not achieve good faith effort documentation. While the low bidder reported \$23,000 in MWBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the MWBE participation could not be confirmed.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
