RESOLUTION No. 2019- B-0

A RESOLUTION of the Board of County Commissioners of Orange County, Florida approving the issuance by the Orange County Health Facilities Authority of its Hospital Revenue Bonds (Orlando Health Obligated Group), in one or more series and in an aggregate principal amount not to exceed \$275,000,000 and the loan of the proceeds thereof to Orlando Health, Inc., a Florida not-for-profit corporation, and Orlando Health Central, Inc., a Florida not-for-profit corporation.

WHEREAS, the Orange County Health Facilities Authority (the "Authority") has been created by the Board of County Commissioners of Orange County, Florida (the "Board of County Commissioners") pursuant to the Health Facilities Authorities Law, Part III of Chapter 154, Florida Statutes (the "Authority Act"), and is authorized under the Authority Act, to issue revenue bonds for the purpose of financing and refinancing health care facilities for not-for-profit corporations located within Orange County, Florida, and refunding bonds previously issued under the Authority Act; and

Whereas, Orlando Health, Inc., a Florida not-for-profit corporation ("Orlando Health") and Orlando Health Central, a Florida not-for-profit corporation ("Health Central," and together with Orlando Health, the "Borrowers"), have requested the Authority to issue its Hospital Revenue Bonds (Orlando Health Obligated Group), in one or more series and in an aggregate principal amount not to exceed \$275,000,000 (the "Bonds"), and to loan the proceeds from the sale of the Bonds to the Borrowers; and

WHEREAS, the proceeds from the sale of the Bonds will be used for one or more of the following purposes: (a) to finance, refinance, or reimburse the Borrowers for their payment of the costs of certain capital improvements to and equipment for certain of the health care facilities of the Borrowers described below; (b) to refund all or a portion of the outstanding Orange County Health Facilities Authority Hospital Revenue Bonds (Orlando Health, Inc.), Series 2009 (the "Prior Bonds"); (c) to pay a portion of the interest to accrue on the Bonds, if deemed necessary or desirable; and (d) to pay certain costs of issuance of the Bonds; and

WHEREAS, the proceeds of the sale of the Bonds, when and if issued, will be used, and the proceeds of the Prior Bonds were used to finance, refinance or reimburse the costs of acquiring, constructing, improving or renovating the facilities (including related land improvement costs) listed below and the costs of acquiring and installing equipment (including, but not limited to, medical equipment, computer equipment, office equipment and general building equipment and fixtures) to be used at the facilities listed below;

WHEREAS, the initial owner, operator or manager, a general functional description, and the location of each such facility, and the estimated maximum aggregate principal amount of Bonds to be issued with respect to each such facility are listed below:

Horizon West Hospital, a 103-bed acute care hospital and related medical clinics, medical offices and ancillary facilities under construction located on a 74 acre parcel of land on Porter Road (having a mailing address of 17000 Porter Road), immediately east of Highway 429 (Daniel Webster Western Beltway), bordered on the west by County Road 545/Avalon Road and on the north by Porter Road, in Winter Garden, Florida----\$150,000,000. The facilities listed above in this paragraph 3 will be owned and/or operated by Health Central or its sole corporate member, Orlando Health.

- 6. Equipment located at the clinical services buildings listed below in the amounts and at the following addresses in Orlando, Florida: 601 West Michigan Street-----\$100,000; 2901 Curry Ford Road-----\$60,000; and 925 South Orange Avenue-----\$80,000. The equipment listed above in this paragraph 6 is owned by Orlando Health.

7. Equipment located at warehouse having an address of 118 Grant Street in Orlando, Florida----\$6,000. The equipment listed above in this paragraph 7 is owned by Orlando Health.

WHEREAS, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), requires the approval of the issuance of the Bonds by the Board of County Commissioners, as the "applicable elected representative" under Section 147(f) of the Code, after a public hearing following reasonable public notice; and

WHEREAS, attached hereto as *Exhibits A* and *B*, respectively, are copies of the publisher's affidavit evidencing publication of the Notice of Public Hearing and the Minutes of a Public Hearing held by the Authority on January 3, 2019;

Now, THEREFORE, Be It Resolved by the Board of County Commissioners of Orange County, Florida, as follows:

- Section 1. The issuance of the Bonds by the Authority in one or more series and in an aggregate principal amount not to exceed \$275,000,000 for the purposes set forth above is hereby approved solely for purposes of Section 147(f) of the Code.
- Section 2. The approval given herein shall be solely for the purpose of satisfying the requirements of Section 147(f) of the Code and shall not be construed as (i) an endorsement of the creditworthiness of the Borrowers; (ii) a recommendation to any prospective purchaser to purchase the Bonds; (iii) the evaluation of the likelihood of the repayment of the debt service on the Bonds; or (iv) an approval of any zoning application or any regulatory permit required in connection with the above-described facilities, and this Board shall not be construed by virtue of its adoption of this Resolution to have waived, or be estopped from asserting, any rights or responsibilities it may have in that regard.
- Section 3. Nothing contained in this approval shall be deemed to create any obligation or obligations of Orange County, Florida or the Board of County Commissioners of Orange County.
 - Section 4. This Resolution shall take effect immediately upon its adoption.
