

Parcel A: High School Site

A portion of the Northeast 1/4 of Section 15, Township 20 South, Range 27 East, Orange County, Florida, being more particularly described as follows:

COMMENCING at the northeast corner of said Section 15, thence S 89° 44′ 14″ W, along the north line of said Section 15 for 30.00 feet; Thence, S 00° 18′ 10″ E, along the westerly right of way line of Round Lake Road, said line running parallel with and 30.00 feet westerly of the East line of said Section 15, for 29.98 feet, to the POINT OF BEGINNING of the lands herein described:

Thence, S 00° 18' 10" E, along the said westerly right of way of Round Lake Road, for 2333.31 feet, to the beginning of a tangent curve concave northwesterly and having a radius of 240.50 feet; Thence, southwesterly along the arc of said curve, subtended by a chord which bears S 44° 50′ 50″ W and a chord distance of 341.01 feet, through a central angle of 90° 17' 58", an arc distance of 379.03 feet, to the point of tangency of said curve; Thence, S 89° 59' 49" W, along the northerly right of way line of Sadler Road, said line running parallel with and 30.00 feet northerly of, the south line of the northeast 1/4 of Section 15, for 2402.58 feet, to a point lying on the northerly right of way of said Sadler Road and the west line of the northeast 1/4 of Section 15; Thence, N 00° 13' 03" W, along the said west line of the northeast 1/4 for 422.00 feet, to the north line of the south 452 feet of the southwest 1/4 of the northeast 1/4 of Section 15; Thence, N 89° 59' 48" E, along the said north line of the south 452 feet, for 1335.25 feet, to the west line of the east 1/2 of the northeast 1/4 of Section 15; Thence, N 00° 02' 35" W, along the west line of the east 1/2 of the northeast 1/4 of Section 15, for 2147.15 feet to a point on the apparent southerly right of way of an un-named road, said southerly right of way line being situated 30 feet southerly of and running parallel with the north line of the east 1/2 of the northeast 1/4 of Section 15; Thence, N 89° 44′ 14" E, along said apparent right of way line, for 1295.52 feet, to the POINT OF BEGINNING and close.
