# ACTION REQUESTED:

Approval to award Invitation for Bids, Y19-711-RC Parks Camp Joy Sewer & Sanitary Force Main, to the low responsive and responsible bidder, Uribe Site Development, Inc., in the total contract award amount of \$419,000.

#### PROCUREMENT:

Work will take place at The Orange County Park Camp Joy, which will comprise of Utility Connections. Contracted work will include the addition of a wastewater force main, wastewater lift station, connection of existing building to the new wastewater system, water/fire lines, fire hydrants, septic tank abandonment, roadway crossing, and sodding. Work will include the bid additive which will tie in the Kelly Park Supervisor's residence to the force main. The project is located in District 2.

## FUNDING:

Funding is available in account number 1023-043-0263-3810.

## APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

## REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted from Uribe Site Development, Inc. is considered reasonable based on the engineer's estimate. References provided were satisfactory for this type of work and Uribe Site Development, Inc., has been determined to be responsible. Therefore, award is recommended to Uribe Site Development, Inc. This work is associated with an existing Inter-Local Agreement with the City of Apopka, reimbursing us for oversizing of pipes.

The Business Development Division evaluated the 4 lowest bids of the 6 bids submitted for this project and found the apparent low bidder Orange County MWBE firm Uribe Site Development, Inc. is bidding as a prime. Therefore, Uribe Site Development, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the MWBE Ordinance. In the event this requirement is not achieved, other MWBE's will have to be included to achieve the 25% MWBE goal. Uribe Site Development, Inc. reported self-performing 94.99%. They reported 1.19% other MWBE participation in their bid and met the MWBE participation goal. Please note the following certified MWBE participation:

Mbe-hmUribe Site Development, Inc.\$398,000Wbe-wfFlash-Rite, Inc.\$5,000Total MWBE Participation\$403,000 (96.18%)

The second low bid submitted by Orange County MWBE firm Valencia Construction Group, Inc. is bidding as a prime. Therefore, Valencia Construction Group, Inc. is required to selfperform no less than 51% of the contract per Sec. 17-321 in the MWBE Ordinance. In the event this requirement is not achieved, other MWBE's will have to be included to achieve the 25% MWBE goal. Valencia Construction Group, Inc. reported self-performing 78.03%. They reported 0% other MWBE participation in their bid and met the MWBE participation goal.

The third low bid submitted by Cathcart Construction Company-Florida LLC did not achieve good faith effort documentation and reported 12.01% MWBE participation in their bid.

The fourth low bid submitted by Killebrew, Inc. did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.
