The Orange County Board of County Commissioners will conduct public hearings on **March 12, 2019**, at **2 p.m.**, or as soon thereafter as possible, in the County Commission Chambers, First Floor, County Administration Center, 201 South Rosalind Avenue, Orlando, Florida. Applicant: Erika Hughes, VHB, Inc., Monk Property Planned Development, Case # LUP-17-06-213

Consideration: Request to rezone three (3) parcels containing 49.60 gross acres from A-1 (Citrus Rural District) to PD (Planned Development District), in order to construct 81 single-family detached residential dwelling units utilizing five (5) internal Transferable Developable Rights (TDR) credits. No waivers are associated with this request; pursuant to Orange County Code, Chapter 30.

Location: District 1, property located at 13000 and 13003 Orange Isle Drive; or generally west of Duncaster Street, south of Little Lake Sawyer, and north of Overstreet Road; Orange County, Florida (legal property description on file in Planning Division)
