

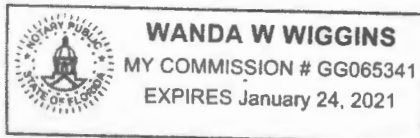

Applicant: Rob Stephenson, Curry Ford Car Wash, LLC, RaceTrac – Curry Ford Planned Development – Case # LUPA-18-09-294
Consideration: To rezone one (1) parcel containing 2.75 gross acres from A-2 (Farmland Rural District) to PD (Planned Development District) and incorporate the parcel into the RaceTrac – Curry Ford PD in order to construct a 5,000 square foot car wash and associated infrastructure; pursuant to Orange County Code, Chapter 30.
