Pursuant to section 2-210, Article VI, of the Orange County Code, the Affordable Housing Advisory Board (AHAB) respectfully submits the following answers to questions provided by the Membership and Mission Review Board (MMRB) as part of the sunset review justification process.

1. Please state the purpose and/or mission of the advisory board. Is the advisory board serving the purpose for which it was created?

The purpose of the Affordable Housing Advisory Board (AHAB) is to review policies, procedures, ordinances, regulations, and recommend specific monetary and non-monetary incentives to encourage or facilitate affordable housing. The AHAB is serving the purpose for which it was created.

2. What are the current need(s) of the county being served by the advisory board?

The AHAB serves to review a list of affordable housing strategies as required by the Local Housing Assistance Plan (LHAP), and provide recommendations to those strategies. The board also reviews policies and procedures pertain to affordable housing and recommends amendments to the LHAP.

3. What are the accomplishments of the advisory board?

The accomplishments of the advisory board are:

- Evaluate and recommend affordable housing strategies.
- Discuss issues relating to affordable housing and recommend solution.
- Develop funding priorities.
- Promote public awareness and engagement to county staff.

4. <u>Is there another public or private board that would better serve the function of the advisory board? If so, please list the board and explain why it would better serve the function.</u>

Currently there are no public or private boards that can replace the function of the AHAB.

5. Should the resolution creating the advisory board be amended to enable the advisory board to better serve the purpose for which it was created? If so, how should the resolution be amended?

Currently, there is no need to amend the resolution creating the AHAB.

Currently, there is no need to modify the advisory board's membership requirements.

- 1. Please state the purpose and/or mission of the advisory board. Is the advisory board serving the purpose for which it was created? The purpose of the Children Family Services Board (CFSB) is to advocate for the youth at Great Oaks Village (GOV) and the Youth Shelter (YS). The CFSB also solicits donations for the youth and families in Orange County especially the ones receiving services through Youth and Family Services Division. The advisory board currently serves the intended purpose of its original creation.
- 2. What are the current need(s) of the county being served by the advisory board? The current needs remain the same as in the past. It is lucrative for the CFSB to continue to fundraise for the children and families. In addition, the CFSB also provides support by advocating with community partners to assist in providing an array of services.

Dear Mr. Warlow:

This is in response to your letter of January 19, 2018 regarding the sunset date and review by the MMRB of the Citizens' Commission for Children Advisory Board.

Following are the questions listed, accompanied by my response.

1. Please state the purpose and/or mission of the advisory board. Is the advisory board serving the purpose for which it was created?

The Orange County Citizens' Commission for Children (CCC) Advisory Board was created for the purpose of improving life for children, youth, and families in Orange County, Florida. Yes, the board continues serving the purpose for which it was created. It continues to review the planning and coordination of services for and on behalf of children, youth, and families in Orange County.

The Citizens' Commission for Children continues to provide information that leads to sound practices for service provision. Through annual reports, the advisory board updates the Board of County Commissioners (BCC) about children's issues in the County, assists with strategic planning for children and family services, and provides a forum to exchange ideas and promote synergies among service providers.

2. What are the current need(s) of the county being served by the advisory board?

The CCC Advisory Board provides leadership and advocacy necessary to provide recommendations that assist with funding programs and services to improve the lives of children and their families in Orange County. The Advisory Board is involved in strategic planning, needs assessments, and evaluation of program performance.

The current needs of Orange County citizens being served by the Board are vast, and represent diverse needs in the communities targeted. Some of the identified needs include, but are not limited to: academic enrichment activities, counseling, case management, family medical services, afterschool programming, senior services, childcare, vocational education, English for Speakers of Other Languages (ESOL) classes, emergency services, and various

auxiliary services through unfunded partnerships. In many cases, the Advisory Board is instrumental in identifying these needs and expanding service delivery.

Further, the CCC Advisory Board advocates to bring together social service programs for children and their families that take an intentional, coordinated approach to service delivery. For example, barriers to obtaining employment are eliminated through the County's investment in childcare stipends. For every dollar invested, the County receives a dollar for dollar up to a dollar for fifteen dollar match. Through the actions of this board, children and families are provided with more opportunities to succeed.

3. What are the accomplishments of the advisory board?

The CCC Advisory Board meets quarterly to ensure that agencies are held accountable for establishing programs which are cost effective. The Advisory Board takes into consideration critical issues, including the assurance of a proven community need, that funding is well spent for specific programs, and that agency effectiveness and efficiency in providing these services is well documented. As good stewards of public dollars, the CCC is the only funder that recaptures at the end of the contract year for underutilized units of service.

Through recommendations of the Advisory Board, additional funding has been provided for services in the Neighborhood Centers for Families (NCFs) and the After School Zone (ASZ), all of which focuses on strengthening family relationships through education, activities, and community service. Ongoing leadership and advocacy has resulted in additional positions and enhancement of much-needed services in Orange County communities.

The ASZ continues to be recognized for excellence in programming, most recently at the Florida After School Alliance (FASA) for out-of-school programming. The Citizens' Commission for Children has received numerous awards and accolades, including the statewide advocacy award for out-of-school programming.

The Advisory Board's leadership resulted in the establishment of five (5) lending libraries located throughout Orange County to promote literacy and family engagement as a part of the Let's Read Campaign established by Mayor Jacobs.

4. Is there another public or private board that would better serve the function of the advisory board? If so, please list the board and explain why it would better serve the function.

No. The Citizens' Commission for Children is unique in its role with involvement and participation of demographically representative members.

5. Should the resolution creating the advisory board be amended to enable the advisory board to better serve the purpose for which it was created? If so, how should the resolution be amended?

The current board structure continues to meet the needs of the community with its structure remaining appropriate for its intended purpose. It is recommended that this board meets six times during a fiscal year, which would be every two months instead of quarterly.

6. Should the advisory board's membership requirements be modified? If so, how should the requirements be modified?

No. The advisory board's membership requirements are suitable for its purpose.

7. What are the direct and indirect costs of maintaining the advisory board?

The direct costs to the County are minimal. Indirect costs include only staff time and materials needed to carry out the functions of supporting the board.

The following responses have been prepared to serve as an addendum to the original sunset review responses submitted to your office dated March 30, 2018. Since that time, the Orange County Board of County Commissioners (BCC), by Board Resolution, voted to increase the membership of the Citizens' Commission for Children's Advisory Board as well as allow for the creation of subcommittees. As a result, responses to items numbered 5 and 6 on the original correspondence have been updated and the responses are provided below:

5. Should the resolution creating the advisory board be amended to enable the advisory board to better serve the purpose for which it was created? If so, how should the resolution be amended?

The resolution creating the Citizens' Commission for Children's Advisory Board was amended on October 30, 2018 by the Board of County Commissioners, Resolution 2018-M-44. Effective January 1, 2019, the Citizens' Commission for Children's Advisory Board may create subcommittees as necessary, and engage members of the healthcare community for their experience and expertise in the health care arena.

6. Should the advisory board's membership requirements be modified? If so, how should the requirements be modified?

The membership requirements of the Citizens' Commission for Children's Advisory Board has been modified by Resolution 2018-M-44, as adopted by the Board of County Commissioners on October 30, 2018.

Effective January 1, 2019, the membership of the Commission consists of fifteen Nine members are appointed by the Board of County Commissioners, five members are voting ex officio positions, and one member is a member of the Board of County Commissioners or the County Mayor.

The ex officio positions include the Orange County superintendent of schools, or his/her designee; a local school board member; the district administrator for the local district of the Department of Children and Families, or his/her designee; the Director of the Florida Department of Health or his/her designee; and a judge assigned to handle juvenile cases in Orange County to be designated by the chief judge of Orange County.
