

APPENDIX "A" LEGAL DESCRIPTION

Commence at the Southwest Corner of Section 29, Township 21 South, Range 30 East, Orange County, Florida, thence run S 88°28'00" E along the South line of said Section 29, for a distance of 254.47 feet to the Point of Beginning; said South Section line also being the North line of the PLAT OF MAITLAND SHORES, SECOND ADDITION, as recorded in Plat Book T, Page 7 of the Public Records of Orange County, Florida, and also being the South line of the PLAT OF MAITLAND POINT, as recorded in Plat Book 12, Page 94 of the Public Records of Orange County, Florida; thence continue S 88°28'00" E for a distance of 314.20 feet to a point of curvature of a curve concave Northeasterly lying on the Westerly right of way line of Horatio Avenue, also known as State Road 436A, as recorded in Official Record Book 2060, Pages 294-298 of the Public Records of Orange County, Florida; said line being parallel to and 88.00 feet West of the Westerly line of the PLAT OF COVE - COLONY, as recorded in Plat Book 8, Pages 61-62 of the Public Records of Orange County, Florida; said Westerly line also being the Easterly right of way line of Horatio Avenue; said curve having a radius of 1250.23 feet, a chord bearing of N 43°54'20" W, a chord distance of 10.57 feet, and a central angle of 00°29'04"; thence run Northwesterly along the arc of said curve for a distance of 10.57 feet to a point of tangency; thence run N 43°39'48" W along said Westerly right of way line for a distance of 195.40 feet to a point of curvature of a curve concave Southerly, having a radius of 17.00 feet, a chord bearing of N 88°40'09" W, a chord distance of 24.04 feet, and a central angle of 90°00'42"; thence run Northwesterly along the arc of said curve for a distance of 26.71 feet to a point of tangency; thence run S 46°19'30" W for a distance of 204.36 feet to the Point of Beginning.
