REMARKS:

The County and the City of Orlando jointly own and manage the lands known as Conserv II, which were purchased under grant funding from the U.S. EPA and as a result of the grant certain restrictive covenants were imposed upon the lands pursuant to the terms of a grant agreement between the parties. The County and the City of Orlando requested the U.S. EPA to release 1,397.67 acres of those lands to maximize the benefit to the Conserv II project. Due to the historical successful implementation and expansion of the project over several decades of operation, U.S. EPA has agreed to release all interests of the U.S. EPA in such 1,397.67 acres.
