The District Nine Medical Examiner Office requests funds for a microscope. Due to the increase in caseload, the office needed to increase the number of medical examiners on staff. As such, District 9 also needs to increase the number of microscopes on hand for all the doctors to have one so that they will be able to inspect the histology slides they requested on specific medical examiner cases. Sharing microscopes can cause unnecessary delays and all doctors should be given the same necessary tools to complete their work. By allocating funds for the microscope, there will not be a delay in permitting the new doctor from reading slides. It will also minimize the time necessary for the doctor to dictate those findings and include them in the autopsy reports the doctor generates on those cases.
