Procurement of Banking and Treasury Management Services

On February 4, 2019, the Comptroller issued Request for Proposals (RFP) Y19-1049 to request proposals to provide the Orange County Board of County Commissioners and the Orange County Comptroller with comprehensive banking and treasury management services. The agreement would be executed by the Mayor and the Comptroller. The term of the contract would be three years with three optional one-year renewals. The RFP was issued to qualified banks requesting the following services:

- Collection and deposit services including lockbox, branch and cash vault deposit, deposit reconciliation, and merchant services.
- Concentration and disbursement services including positive payment, web-based banking, and check reconciliation.
- Account maintenance services including automated cash vault and imaging.
- Interest bearing demand deposit accounts.

The RFP committee was comprised of four Comptroller employees and two employees from the Board's staff. Wells Fargo was the only bank to submit a proposal, which the committee reviewed. The Comptroller needs a banking services contract as treasurer for the County.

Authorization to negotiate, with execution by the Mayor, a triparty contract between Wells Fargo Bank, the Orange County Board of County Commissioners, and the Orange County Comptroller for comprehensive banking and treasury management services.
