ACTION REQUESTED:

Approval to award Invitation for Bids Y19-168-AV, Fire Protection Systems Preventative Maintenance and Repairs, to the low responsive and responsible bidder, National Fire Protection, LLC, in the estimated contract award amount of \$648,946.85 for Lot A and \$233,948.50 for Lot B for the base year. Further request authorization for the Procurement Division to renew the contract for option years one and two.

PROCUREMENT:

This contract will provide preventative maintenance and repairs to fire protection systems.

FUNDING:

Funding is available in accounts - 0001-043-1713-3810, 0001-043-1715-3810, 0001-043-1717-3810, 0001-043-1718-3810, 0001-043-1719-3810 for Lot A and 1009-034-0672-3810, 1009-034-0692-3810 for Lot B.

APPROVALS:

The Facilities Management and Business Development Divisions concur with this recommendation.

REMARKS:

Three bids were received in response to this Invitation for Bids (IFB) and were evaluated for responsiveness, responsibility, and price reasonableness. Impact Fire Services, LLC was deemed non-responsive for failing to provide the revised bid response form. Fire & Life Safety America was deemed non-responsive for failing to provide a complete revised bid response form and failure to provide required documentation identified in the IFB.

Services covered by this contract include inspection, testing, and as needed maintenance and repair services. National Fire Protection, LLC has the necessary manpower and equipment to perform this contract. Staff has determined that bid prices are reasonable based on comparison to previous contract prices with an increase in services. National Fire Protection, LLC meets all specifications and requirements of the solicitation. Therefore, recommendation for award is made to National Fire Protection, LLC.
