REMARKS:

On November 13, 2012, the Board approved an Easement Agreement which granted City of St. Cloud, Tohopekaliga Water Authority, Orange County, Polk County, and Reedy Creek Improvement District (RCID) permission to enter upon property owned by Walt Disney Parks and Resorts U.S., Inc. for the purpose of monitoring wetland or lake conditions and surface water and/or shallow groundwater levels.

TERMINATION AND RELEASE OF EASEMENT AGREEMENT

THIS TERMINATION AND RELEASE OF EASEMENT AGREEMENT (this "Termination and Release"), dated as of the day of day of dord, 2019, is by and between WALT DISNEY PARKS AND RESORTS U.S, INC., a Florida corporation ("Grantor") and CITY OF ST. CLOUD, a municipal corporation, TOHOPEKALIGA WATER AUTHORITY, an independent special district organized under the laws of the State of Florida, ORANGE COUNTY, a charter county and political subdivision of the State of Florida, POLK COUNTY, a charter county and political subdivision of the State of Florida, POLK COUNTY, a charter county and political subdivision of the State of Florida, and REEDY CREEK IMPROVEMENT DISTRICT, an independent special district created under the laws of the State of Florida (collectively referred to as the "Grantees").

WITNESSETH:

WHEREAS, by Easement Agreement dated November 13, 2012 and recorded as Doc #20120634406, Public Records of Orange County, Florida (the "Easement Agreement"), Grantor granted an access easement to Grantees over certain of Grantor's property, as more particularly described in the Easement Agreement ("Grantor's Property"), for the purpose of monitoring certain wetlands and/or surface waters on or abutting Grantor's Property; and

WHEREAS, Grantor and Grantees desire to terminate the Easement Agreement and release Grantor's Property in its entirety from the Easement Agreement.

NOW, THEREFORE, in consideration of the foregoing premises, the mutual agreement of the parties hereto, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. <u>Recitals and Capitalized Terms</u>. The above recitals are incorporated herein by reference, and all capitalized terms used in this Termination and Release, and not otherwise defined herein, shall have the same meaning ascribed thereto in the Agreement.

2. <u>Termination and Release of Easement Area</u>. The Easement Agreement is hereby terminated and, as a result, Grantees do hereby forever release Grantor's Property from the terms of the Easement Agreement. Grantor's Property shall no longer be encumbered by, and may be used, sold,

transferred and/or conveyed completed free from, the terms of the Easement Agreement and the Easement Agreement is terminated and of no further force and effect.


