Fire Rescue Department

With the appointment of Jim Fitzgerald as the new Chief of the Orange County Fire Rescue Department (OCFRD) comes the opportunity to select a new Deputy Fire Chief. It is my pleasure to appoint Division Chief David Rathbun to this important role. Chief Rathbun has served a 29-year career with the OCFRD, having begun his career in 1989 as a Firefighter EMT. Chief Rathbun has served in a variety of important roles in the department during his career, having served the past ten years as a Division Chief. In this capacity, Chief Rathbun has overseen each of the department's responsibilities in Planning and Technical Services, as well as Operations and Logistics.

Chief Rathbun has been a valuable part of the OCFRD leadership team, and his extensive background will continue to be an asset to our fire management team. Chief Rathbun holds a bachelor of science degree in business management/marketing from the University of Phoenix, as well as a master of science degree in public administration from Barry University. Chief Rathbun's promotion will be effective June 16, 2019, at an annual salary of \$140,500. His resume is attached for your reference.

Along with the promotion of Chief Rathbun comes the opportunity to promote a new Division Chief in the department. It is my honor to appoint Assistant Chief LaShun Nale-Stadom to this important role. Chief Nale-Stadom has over 17 years' experience with OCFRD, having begun her career with the department in 2002 as a Firefighter/Paramedic. Chief Nale-Stadom has served in a variety of roles within the department, and most recently served as the Assistant Chief over Training and Professional Development.
