ACTION REQUESTED:

Approval to award Invitation for Bids Y19-744-RC, Magnolia Park & Eco-Tourism Utility Extension, to the low responsive and responsible bidder, Uribe Site Development, Inc. in the total contract award amount of \$ 484,000.

PROCUREMENT:

The project includes an extension of sanitary sewer and drinking water system to Magnolia Park and Eco-Tourism Center. Work includes placement of three E-one package lift stations, two standard package lift stations, and gravity sanitary sewer system to replace existing on site sewage disposal. The project is located in District 2.

FUNDING:

Funding is available in account number 8191-021-0332-6310 and 1023-021-0332-6310.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted from Uribe Site Development, Inc. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Uribe Site Development, Inc. has been determined to be responsible. Therefore, award is recommended to Uribe Site Development, Inc.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: Y19-744-RC / Magnolia Park & Eco-Tourism Utility Extension

Business Development Division evaluated the 3 lowest bids of the 6 bids submitted for this project. Two of the bidders were Minority Business Enterprise (MBE) firms, Uribe Site Development, Inc and Valencia Construction Group, Inc. The scope of services for the Magnolia Park & Eco-Tourism Utility Extension had Minority/Women Business Enterprise availability at the prime and sub-contract level. At least fifty-nine M/WBE firms are certified to provide general contracting, site work, electrical or lab testing services.

The apparent low bidder Orange County certified MBE firm Uribe Site Development, Inc. is bidding as a prime. Therefore, Uribe Site Development, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the MWBE Ordinance. In the event this requirement is not achieved, other certified MWBE's will have to be included to achieve the 25% MWBE goal. Uribe Site Development, Inc. reported self-performing 85.95%. They reported 0% other MWBE participation in their bid and met the MWBE participation goal. Please note the following certified MWBE participation:

The second low bid submitted by Brownies Septic & Plumbing did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

The third low bid submitted by Carr & Collier, Inc. met the MWBE participation goal and reported 25.06% MWBE participation in their bid.
