Approval to award Invitation for Bids Y19-1095-PD, Web and Document Accessibility Services, to the low responsive and responsible bidder, Onix Networking Corporation in the estimated contract award amount of \$171,600 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1year terms.

### **REMARKS**:

Eight bids were received in response to this Invitation for Bids and were evaluated for price, responsiveness, and responsibility. Onix Networking Corporation is the low responsive and responsible bidder. The bid submitted by NetCentric Technologies dba Common Look was determined to be non-responsive due to qualifying their bid. Newgen North America was determined to be non-responsive do to not submitting the revised Bid Response Form.
