ACTION REQUESTED:

Approval to award Invitation for Bids Y19-749-RC, Orange County Fire Rescue Fuel Tank Automation and Replacement, to the low responsive and responsible bidder, Café Construction & Development, Inc. in the total contract award amount of \$2,005,571 inclusive of additive one.

PROCUREMENT:

The project includes installation of electronic fuel monitoring systems at multiple fuel dispensing locations at existing fire stations fuel pump and tank. The base bid includes 20 stations and additive one includes five additional stations. The project is located in all Districts.

FUNDING:

Funding is available in account number 1009-034-0772.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Two bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted from Café Construction & Development, Inc. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Café Construction & Development, Inc. has been determined to be responsible. Therefore, award is recommended to Café Construction & Development, Inc.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: **Y19-749-RC / Orange County Fire Rescue Fuel Tank Automation and Replacement – Base Bid + Additive 1**

The Business Development Division evaluated the two bids submitted for this project and found the apparent low bidder Orange County Minority/Women Business Enterprise firm Café Construction & Development, Inc. is bidding as a prime. Therefore, Café Construction & Development, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Café Construction & Development, Inc. reported self-performing only 29.33%. They reported 3.89% other M/WBE participation in their bid and did not achieve good faith effort documentation. Please note the following certified M/WBE participation:

The second low bid submitted by Orange County M/WBE firm Power Engineering Group, Inc. is bidding as a prime. Therefore, Power Engineering Group, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Power Engineering Group, Inc. reported self-performing 53.69%. They reported 0% other M/WBE participation in their bid and met the M/WBE participation goal. This bid was not within the M/WBE sliding scale range to be awarded this contract over the low bidder.
