Transportation, Inc. for the Design of Grade Crossing Surface at CSX

Railroad Crossing No: 621488H on Exchange Drive

On March 26, 2019, the Board approved addendum to the Master Agreement for the subject Railroad Crossing #621488H. However, due to material changes to this Addendum by CSX Transportation, Inc. (CSXT) (changing milepost from A-797.17 to AOC-800.0); we are now resubmitting this Addendum for Board approval.

On October 5, 2010, the County entered into a Master Construction Agreement with CSXT establishing the terms and conditions for all future County initiated railroad projects. Therefore, as per the terms of this agreement, the County would be responsible for the repair or replacement of the grade crossing surface at the CSXT railroad tracks on Exchange Drive. This crossing surface is in poor condition and needs to be brought to current standards of grade crossing surface.

In addition, as per the agreement, the County is submitting the Project Addendum to Master Agreement to CSXT for a preliminary engineering design of a new grade crossing surface. The cost of the preliminary engineering design is \$15,000, and funds are available in Account #1002-072-5086-3197.

The County Attorney's Office has reviewed the Addendum and found it acceptable.

## PROJECT ADDENDUM TO MASTER AGREEMENT
