ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1047-AH, Pest Control Services for the Orange County Convention Center, to the low responsive and responsible bidder, Massey Services, Inc., in the estimated contract award amount of \$157,200 for a 3-year term. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PURPOSE:

This contractor will furnish all the services and supplies required to ensure effective pest control at the Convention Center.

FUNDING:

Funding is available in account number 4430-035-0927-3810.

APPROVALS:

The Convention Center and Business Development Division concur with this recommendation.

REMARKS:

Three bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Terminix Commercial, Inc. was deemed non-responsive for qualifying their bid with additional terms and conditions. Massey Services, Inc. was determined to be the low responsive and responsible bidder and is recommended for award. The prices are considered reasonable based on comparison of previous contracts for the same scope of work. The offer was compared to past and current Orange County term contracts and was 9% lower than the current contract.
