### **RECOMMENDATION:**

Selection of one firm and two ranked alternates to provide Professional Engineering Services for the Final Design of Pine Hills Road Pedestrian Safety Project, Request for Proposals Y19-811-CH, from the following firms listed alphabetically. Further request the Board authorize the execution of the final contract by the Procurement Division provided that it does not exceed the budget of \$1,200,000.

AVCON, Inc.  
Johnson, Mirmiran & Thompson, Inc.  
WSP USA, Inc.

The proposals were evaluated by the Procurement Committee on June 12, 2019. Commissioner Emily Bonilla was assigned to the Procurement Committee.

### **PURPOSE:**

The purpose of this contract is to select a firm to provide professional engineering services for the final design of Pine Hills Road pedestrian safety project. The project is located in District 6.

### **DISCUSSION**

The Consultant shall prepare plans for the construction of pedestrian and bicyclist safety features for Pine Hills Road from West Colonial Drive (S.R. 50) to Bonnie Brae Circle. The improvements for pedestrian and bicycle safety shall be provided as identified in the Pine Hills Road Pedestrian/Bicycle Safety Study. The construction plans shall be split for construction in two

Phases. Phase 1, the North Segment, is from Figwood Lane to Bonnie Brae Circle and includes the intersection of Silver Star Road and Pine Hills Road. Phase 2, the South Segment, is from Colonial Drive (S.R. 50) to Figwood Lane. The Consultant shall also be responsible for the design of a portion of the Pine Hills Trail, which shall run along Belco Drive from Silver Star Road to Pine Hills Road and along Pine Hills Road from Silver Star Road to Bonnie Brae Circle as part of Phase 1.

Three firms submitted proposals in response to this Request for Proposals.
