### ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1083-AV, Janitorial Services - Orange County Sun Rail Stations, to the low responsive and responsible bidder, Contractors Enterprises, Inc., in the estimated contract award amount of \$115,424 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

### PROCUREMENT:

To provide janitorial services at Orange County Sun Rail stations.

### APPROVALS:

The Facilities Management Division and the Business Development Division concur with this recommendation.

### REMARKS:

Eight vendors submitted bids in response to the Invitation for Bids. The bids were evaluated for price, responsiveness, and responsibility. Padegenis Cleaning, Inc., Gemilang Solutions, LLC, Building Maintenance Services, Inc., American Janitorial Maintenance & Services, Inc., and Heavenly Hearts Cleaning Services, Inc. were determined to be non-responsive for failing to submit the correct bid response form.

Staff performed a technical evaluation of the bids and determined that the low bid was reasonable based on, performance and experience. Contractors Enterprises, Inc., was determined to be the low responsive and responsible bidder for the janitorial services listed and is recommended for award.

The scope of services for the Janitorial Services – Orange County Sun Rail Stations had MBE availability. At least thirteen firms are certified. The one (1) Orange County Certified Minority Business Enterprise bidder, New Carpet Cleaning Co., was not within 7% of the low bid for bid awards greater than \$100,000 to \$500,000. Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
