Subject: Award of Invitation for Bids Y19-1078-PD, Recycling of Residential Yard Waste

ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1078-PD, Recycling of Residential Yard Waste, to the low responsive and responsible bidder, Raynor Shine Services, LLC, in the estimated contract award amount of \$2,880,000 for a 3-year term. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PROCUREMENT:

This contract will provide a recycling site for yard waste collected by franchise haulers west of I-4. Most yard waste collected via the franchise contracts is delivered to the Orange County Landfill. However, for efficiency purposes, some of the yard waste collected in the western region of the County needs to be processed at a facility within the vicinity of the collection. This site will facilitate a reduction in truck traffic, improve public safety, and lessen the impact of heavy traffic on the roadways.

FUNDING:

Funding is available in account number 1006-038-1250-3197.

APPROVALS:

The Solid Waste Division and the Business Development Division concur with this recommendation.

REMARKS:

Two bids were received and evaluated for responsiveness, responsibility, and price. Raynor Shine Services, LLC is the lowest responsive, responsible bidder. The bid is considered reasonable based on comparison to prior similar contracts and is within the range of waste recycling costs at other facilities in Florida.
