The **one (1)** Orange County Certified Minority Business Enterprise bidder, GroundTek of Central Florida, LLC **was not within 5%** of the low bid for bid awards greater than \$750,000 to \$2,000,000. Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
