SUBJECT: Managerial Appointment CONSENT AGENDA ITEM SEPTEMBER 10, 2019

It is my pleasure to appoint Dr. Thomas Hall as director of the Office for a Drug Free Community Division in the Health Services Department.

Dr. Hall comes to us from the University of Central Florida (UCF), where he was the associate director of Substance Use Disorders Prevention Services. In this position, he developed and implemented best practices related to health and wellbeing. Additionally, he managed substance use prevention, treatment, and recovery services for a UCF population of over 60,000 students. He provided leadership over university-wide substance use policies and community substance abuse prevention initiatives. Dr. Hall has been an active member of the Orange County Drug Free Coalition since 2004, served on the Heroin Advisory Task Force Education Subcommittee, and currently chairs the One Voice Underage Drinking Implementation Committee and the Higher Education Coalition Committee.

Dr. Hall received his doctorate in sociology in 2016 from UCF. In his new role, Dr. Hall will oversee all operations of the division, including our important initiatives related to the opioid epidemic.

Dr Hall's appointment will be effective September 23, 2019, at an annual salary of \$108,000. His resume is attached for your review.
