ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1052-EB, Term Contract for County Wide Demolition, to the low responsive and responsible bidder, Sunrise Systems of Brevard, Inc. in the total estimated contract award amount of \$232,922.95 for Lot 1 and \$1,129,395.75 for Lot 2 for the base year. Further request authorization for the Procurement Division to exercise contract option years one and two. The estimated contract amount includes every conceivable requirement that may arise during the performance of the contract.

PROCUREMENT:

The work includes regular and emergency demolition and removal of unwanted structures throughout Orange County.

FUNDING:

Funding is available in account numbers 0001-043-0201-3197 for Real Estate Management Division and 0001-068-3220-3197, 0001-068-3221-3197 for Code Enforcement Division.

APPROVALS:

The Real Estate Management Division, Code Enforcement Division, and the Business Development Division concur with this recommendation.

REMARKS:

Two bids were received in response to this Invitation for Bids. ACE Demolition, LLC. failed to submit a bid bond and therefore was determined non-responsive. The bid of Sunrise Systems of Brevard, Inc. was evaluated for responsiveness, responsibility, and price reasonableness. The prices submitted by Sunrise Systems of Brevard, Inc. were compared to their prices for previous contracts for these same services and have been found to be fair and reasonable and consistent with their experience, knowledge, and work methods. Sunrise Systems of Brevard, Inc. has a satisfactory record of performance and has been determined responsible. Therefore, award is recommended to Sunrise Systems of Brevard, Inc.
