SUBJECT: September 10, 2019 — Consent Item Environmental Protection Commission Recommendation for a Variance Request for the Joe Siviglia Dock Construction Permit BD-19-05-053

Joe Siviglia is requesting approval of a dock construction permit with a variance to Orange County Code, Chapter 15, Article IX, Section 15-342(e) (roof height). The project site is located at 5536 Isleworth Country Club Drive, Windermere, Florida 34786. The Parcel ID number is 16-23-28-3899-01-510. The subject property is located on Lake Butler in District 1.

On May 28, 2019, the Environmental Protection Division (EPD) received an Application to Construct a Dock at the subject property. Included with the application was an Application for Variance to Section 15-342(e) to increase the roof height to 14 feet. The maximum roof height allowed by code is 12 feet. There is an existing dock that the applicant proposes to remove before construction of the new dock.

EPD sent notices to all shoreline property owners within 300 feet, as required by Orange County Code. EPD has received no objections to the request.

Pursuant to Orange County Code, Chapter 15, Article IX, EPD staff evaluated the variance request and other required documents. In the application for variance, the applicant's agent indicated that the boathouse roof is about twice as wide as normal, so in order to obtain the optimum roof pitch from an aesthetic and functional perspective, the roof height needs to be increased. There have been no objections from adjacent property owners and there is no perceived environmental harm that will occur if the variance is approved. At the July 31, 2019 public hearing before the Environmental Protection Officer (EPO) was to approve the request for variance to Orange County Code, Chapter 15, Article IX, Section 15-342(e) (roof height). The EPC voted to uphold the recommendation of the EPO and recommended approval of the request for variance.


