SUBJECT: Award of Invitation for Bids Y19-1153-AV, Yard Trash Grinding

ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1153-AV, Yard Trash Grinding, to the low responsive and responsible bidder, Camo Farms, Inc., in the estimated contract award amount of \$2,340,900 for a 3-year term. Further, request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PROCUREMENT:

This contract will provide yard trash grinding for the Solid Waste Division.

FUNDING:

Funding will be available in account 4410-038-1035-3197.

<u>APPROVALS:</u>

The Solid Waste and Business Development Divisions concur with this recommendation.

REMARKS:

Eight bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. X-treme Lawn & Land Development Inc. was determined to be non-responsive for failing to provide a written statement that was requested in the Qualification of Bidders. Camo Farms, Inc. has the necessary manpower and equipment to perform this contract and performs similar services to other local governments in Florida. Therefore, award is recommended to Camo Farms, Inc.

Yard waste grinding supports County sustainability initiatives by reducing the amount of waste disposed in the landfill and diverting this material for reuse. The contracted services turn vegetative waste into mulch that is reused to control erosion on landfill side slopes, construct temporary roadways on the landfills, and to replace dirt as landfill cover material. Additionally, ground yard waste is composted at the yard waste processing area. The finished product is then made available to residents for use.
