#### ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1156-AV, Janitorial Supplies for the Fire Rescue Department, to the low responsive and responsible MWBE compliant bidder, Premier Janitorial Supply. Inc., in the estimated contract award amount of \$633,849.90 for a 3year term. Further, request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

This contract will provide janitorial supplies for the Fire Rescue Department.

#### APPROVALS:

The Fire Rescue Department and Business Development Division concur with this recommendation.

#### REMARKS:

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Nisa Cleaning Systems "LLC" was determined to be non-responsive for failing to provide references. Premier Janitorial Supply, Inc., is a certified MWBE firm whose bid is within the 6% allowed by the solicitation for award to other than the low bidder in accordance with the County's MWBE Ordinance, Section 17-324. Premier Janitorial Supply, Inc. has the necessary manpower and equipment to perform this contract. Therefore, award is recommended to Premier Janitorial Supply, Inc.
