# ACTION REQUESTED:

Approval to award Invitation for Bids Y20-116-TJ, Compressed Gasses Services for Orange County Utilities Laboratory, to the sole responsive and responsible bidder, Matheson Tri-Gas, Inc., in the estimated contract award amount of \$162,550.86 for a 3-year term. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

#### PROCUREMENT:

This contract will provide compressed gasses to the Orange County Utilities Central Laboratory for analytical testing. Compressed gasses are used in conjunction with instrumentation to detect various chemicals that are reported to regulatory agencies.

# REMARKS:

One bid was received in response to this Invitation for Bids and was evaluated for responsiveness, responsibility, and price. The bid is considered reasonable based on a decrease in contract cost by 31% with no reduction in scope. Reference checks were conducted with favorable responses.
