### ACTION REQUESTED:

Approval to award Invitation for Bids Y19-778-CH, Alafaya Trail Sidewalk Improvements, to the low responsive and responsible bidder Parthenon Construction Company, in the estimated contract award amount of \$501,224.65.

### PROCUREMENT:

The project consists of the construction of a sidewalk along the west side of Alafaya Trail from Lake Underhill Road to the S.R. 408 westbound on-ramp, drainage improvements, the extension of existing twin 3'x10' box culverts in the northeast corner of Lake Underhill Road and Alafaya Trail, and construction of a sidewalk along the west side of Alafaya Trail south of Curry Ford Road. Also, additional crosswalk crossings will be added at the S.R. 408 on and off ramps. This project is located in District 4.

### FUNDING:

Funding is available in the account number 1003-072-2841-6311.

## APPROVALS:

The Public Works Engineering Division and Business Development Division concur with this recommendation.

## <u>REMARKS:</u>

Seven bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: Y19-778-CH / Alafaya Trail Sidewalk Improvements

The Business Development Division evaluated the three lowest bids of the seven bids submitted for this project. One of the bidders was an Orange County certified Minority/Women Business Enterprise. The scope of services for this project had Minority/Women Business Enterprise availability. At the time of bid opening, at least 35 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, Parthenon Construction Company, did not achieve good faith effort documentation and reported 9.73% M/WBE participation in their bid. Please note the following certified M/WBE participation:

The second low bid submitted by Orange County Minority/Women Business Enterprise firm Valencia Construction Group, Inc. is bidding as a prime. Therefore, Valencia Construction Group, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Valencia Construction Group, Inc. reported self-performing 92.10%. They reported 0% other M/WBE participation in their bid and met the M/WBE participation goal.

The third low bid submitted by Schuller Contractors Incorporated, did not achieve good faith effort documentation and reported 12.84% M/WBE participation in their bid.

None of the bids were within the M/WBE sliding scale range to be awarded this contract over the low bidder.
