Further request authorization for the Procurement Division to negotiate and execute a 1-year contract with a budget of \$122,000 and renew the contract for four additional 1-year terms.

This item was evaluated by the Procurement Committee on October 9, 2019. Commissioner Mayra Uribe was assigned to the procurement committee.

PROCUREMENT:

The firm will represent Orange County before the U.S. Congress, federal agencies, and the White House to secure federal funding and influence the enactment of legislation beneficial to the County. Specific responsibilities include:

- a. Identify additional areas where federal funding is available to local government.
- b. Represent the County's interest in securing federal funding and assistance for various County efforts and responsibilities from all relevant committees and subcommittees in the federal appropriations process. The firm will provide technical assistance, develop strategy and action plans, and facilitate and initiate communications needed to obtain federal funding.
