SUBJECT: Consent Agenda Item – January 14, 2020 Cooperative Extension Division Employment Agreement

Cooperative Extension in Orange County is administered through, and supported by, the University of Florida in collaboration with Orange County Government. Pursuant to Florida Statutes Section 1004.37(3), recommendations for Extension positions are to be presented for acceptance by the Board.

The University has conducted a search and recommends Hannah Wooten as the new Orange County Extension Agent I, Commercial Horticulture. Ms. Wooten will be filling an existing and budgeted vacant position. In accordance with the existing agreement between the County and the University for this program, the annual salary will be \$51,000 with a 90%/10% split in funding sources between Orange County \$45,900 (90%) and the University of Florida \$5,100 (10%).

Ms. Wooten will be responsible for providing leadership for the development, implementation, and evaluation of Extension education programs for the commercial landscape and pest control industry in Orange County in collaboration with a team of County Faculty, UF Specialists, and local citizen advisors. Ms. Wooten will also work closely with other community organizations and government entities to provide Green Industries – Best Management Practices, Integrated Pest Management, and Florida-Friendly Landscaping Principles[™] for training of members in the commercial landscape industry and conduct commercial pesticide license training and testing for the commercial pest control businesses in Orange County.

Ms. Wooten has completed 50% of her requirements for a Master of Science degree in Agroecology and is expected to graduate in 2021. Job Description:

The Florida Cooperative Extension Service is a partnership between state, federal, and county governments that provides quality, relevant education and research-based expertise to foster healthy people, a healthy environment, and a healthy economy. We are the resource that helps educate Floridians to address issues related to agriculture, natural resources, youth development, families and communities.

University of Florida/IFAS Extension and Orange County Government seek to fill a full-time permanent status-accruing Commercial Horticulture Extension Agent position with a self-starting, energetic, team-oriented individual. As the Agent, you will design, conduct and evaluate community-based extension educational programming for commercial clientele in the areas of Green Industries Best Management Practices, Integrated Pest Management, and Florida-Friendly Landscaping[™] Principles. You will also coordinate with the Florida Department of Agriculture and Consumer Services and the Univ. of Florida to conduct Orange County commercial pesticide license training and testing, and provide management and oversight of the commercial landscape contract for the UF/IFAS Extension Orange County Education Center.

We expect you to have a working knowledge of horticulture and experience with diagnostic skills, best management practices, soils, plant nutrition, arboriculture, and pest identification and management. You will work with other agents, agencies, and groups on cooperative educational efforts designed to produce positive practices with higher impact. You will develop or assist with 4-H Youth Development activities as appropriate.

You will develop and maintain an advisory committee to assess client needs and program priorities. You will create an annual plan of work and report of accomplishment based on the input of the advisory committee. Additional faculty reports will be required. We expect you to employ skills in effective organization and record keeping, and to respond to clients in a timely and professional manner. This position requires you to work with agencies and organizations in interdisciplinary projects, develop creative works (presentations, posters, slide shows, etc.), write non-technical people-friendly publications, seek extramural funding, and participate in professional societies.

You will occasionally assume other responsibilities that benefit the total county extension program as assigned by the County Extension Director and/or the District Extension Director. We expect you to attain promotion and permanent status according to UF guidelines.

Candidates will be reviewed as applications are received, but interviews might not be scheduled until 4 to 6 weeks after the position closing date. As a joint state/county appointment, the hired candidate will follow all policies relating to UF/IFAS Extension and Orange County.

Minimum requirements:

You must have a bachelor's degree in horticulture or a related field. If you have solely a bachelor's degree upon hire, we want you to continue to grow in your career. As such, we expect you to make at least 50% progress towards obtaining your master's degree within the first 6 years of employment. Course work completed within the State University System of Florida comes with a tuition waiver.

A professional schedule that allows for irregular hours is necessary. Proficiency with computer technology, software applications, and internet use is required. A valid driver's license as well as national background screening are requirements of this position.

Preferred qualifications:

Highly desirable are a master's degree, professional experience in the field (Florida Certified Horticulture Professional Certification is a plus), Spanish/English bilingual ability, arborist certification (ISA Certified Arborist is a plus), and familiarity with or willingness to learn webpage design software and online tools in educational technology. Expertise in getting groups to work together for a higher goal, managing competing priorities, and adaptability to handle unexpected situations is a plus for this role. You must be an effective written and verbal communicator, feel comfortable presenting in front of small and large groups, be able to establish solid partnerships, and find innovative ways to attract new audiences.

The annual salary will be \$51,000.00 with a 90%/10 % split in funding sources between Orange County \$45,900.00 (90%) and the University of Florida \$5,100.00 (10%). Please note your employment is contingent upon your passing the county's prescreening process and approval of the Orange County Board of County Commissioners. This offer is also contingent on a successful preemployment screening which includes a review of criminal records, reference checks, and verification of education by the University of Florida. *The beginning date is subject to change based on the date that the background screening results are received. An employee cannot start working until the background screening results are received in HR.

As an Extension Agent I, Commercial Horticulture you will work under the direction of the Orange County Extension Director (CED) and the Central District Extension Director (DED), Dr. Tim Momol. As with all County Extension faculty, your plan of work, report of accomplishments, and annual performance reviews will be under the supervision of the CED & DED. The assigned duties and responsibilities for this position are 100% Extension. Your assignments may be subject to change at the discretion of the CED/DED based on the needs of the department.

Your appointment is subject to the constitution and laws of the State of Florida and the rules and regulations of the Board of Trustees of the University of Florida.

Special conditions of your employment:

- 1. If you propose to engage in any outside activity or have a potential conflict of interest, you shall notify your supervisor in writing (using the proper University of Florida forms) prior to engaging in these activities. Such notification must be done annually (effective July 1 for future academic years) for as long as you continue to engage in such activity or have such conflict of interest.
- 2. There is also considerable travel with evening and weekend meetings, which may or may not be by personal vehicle.
