construct 8 single-family detached
residential dwelling units. The request
also includes the following waivers
from Orange County Code: 1. A waiver
from Section 34-152 (c), to allow for
a twenty (20) foot direct access to
Tract D open space from Windermere
Road, a paved roadway exterior to
the subdivision, in lieu of each lot and
tract interior to each lot and tract
interior to the subdivision shall have a
minimum access width of twenty (20)
feet to a dedicated public paved street,
except in gated communities covered interior to the subalyision shall have a minimum access width of twenty (20) feet to a dedicated public paved street, except in gated communities covered by Article VIII of this chapter. 2. A waiver from Section 34-209, to allow for a minimum five (5) foot high fence and ten (10) foot wide landscape buffer to be provided along the road frontage of tracts e & f (excluding the wetland buffer) to separate the residential subdivision from all adjacent roadways whose average daily traffic volumes are projected to exceed eight thousand (8,000) vehicles within five (5) years of the date of approval of the preliminary subdivision plan, in lieu of a six-foot high masonry wall.
