REMARKS: On December 4, 2018, the Board approved a Conservation Easement (Easement) from Spring Grove Properties, LLC (Spring Grove) to Orange County (County) as a requirement of Conservation Area Impact Permit Numbers CAI-17-02-002, CAI-17-10-025, CAI-18-04-019, and CAI-17-08-022 (Permits) issued by the Orange County Environmental Protection Division (OCEPD). Spring Grove remains the fee simple owner of the lands encumbered by the Easement.

Spring Grove has requested to amend the Easement to correct a scrivener's error in the legal description and sketch of the easement area. OCEPD has confirmed that such amendment is in accordance with the Permits.

Spring Grove to pay all recording fees.

FIRST AMENDMENT TO CONSERVATION EASEMENT

THIS FIRST AMENDMENT TO CONSERVATION EASEMENT (this "First Amendment") is made and entered by and between Spring Grove Properties, LLC, a Florida limited liability company, whose address is 1353 Palmetto Ave., Suite 101, Winter Park, FL 32789 ("Grantor"), and Orange County, a charter county and political subdivision of the State of Florida, whose address is P.O. Box 1393, Orlando, Florida, 32802-1393 ("Grantee").

BACKGROUND

A. Grantor previously granted a conservation easement to Grantee pursuant to that certain Conservation Easement recorded on December 7, 2018, under Document No. 20180708996, in the Public Records of Orange County, Florida ("**Conservation Easement**").

B. The Conservation Easement included a scriveners' error in the legal description and sketch of the Property set forth in Exhibit "A."

C. Grantor remains the sole owner of the Property.

D. Grantor and Grantee wish to enter into this First Amendment to correct the scrivener's error in the legal description and sketch of the Property set forth in Exhibit "A" of the Conservation Easement by replacing the legal description and sketch of the Property with the version attached to this First Amendment as **Exhibit "A."**

In consideration of the promises contained in the Conservation Easement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Grantee agree as follows:

TERMS OF AMENDMENT


