Raftelis Financial Consultants, Inc. Stantec Consulting Services Inc. Willdan Financial Services

Further request authority for the Procurement Division to negotiate and execute a threeyear contract within a budget of \$541,000 and authorization to renew the contract for two additional one-year terms.
