U.S. Department of Agriculture - Child Care Food Program grant

Head Start Division/Community and Family Services Department

On September 19, 2019, the Board approved an estimated budget for the U.S. Department of Agriculture (USDA) Child Care Food Program grant in the amount of \$2,000,386. The USDA, through the Florida Department of Health, awarded this grant to Orange County for the period of October 1, 2019 through September 30, 2020 in the amount of \$1,595,577. This represents a total decrease of \$404,809.

The Child Care Food Program is a federally funded program that reimburses child care providers for serving meals to eligible children. Children enrolled in Head Start are automatically eligible to receive free meal benefits.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.

On September 19, 2019, the Board approved an adopted budget for the Housing Opportunities for Persons with AIDS (HOPWA) grant in the amount of \$4,397,446. The intergovernmental agreement between the City of Orlando and Orange County was awarded in the amount of \$4,507,853, which represents an increase of \$110,407. Funding for the HOPWA program provides housing and case management services for persons living with HIV/AIDS in Orange, Osceola, Seminole, and Lake counties.
