**ACTION REQUESTED:** 

Approval for the Orange County Sheriff's Office to spend \$2,500 from the Law Enforcement Trust Fund to provide an eligible contribution to Embrace Families Foundation, Inc.

PLEASE NOTE:

The Board voted to establish spending limits of 20% for this fund for contributions. At this point in the fiscal year, contributions represent 31% of the total expenditures; however, the restriction applies to total expenditures for the year, at yearend. The Sheriff's Office has stated that they monitor their expenditures, and that they will not exceed the 20% total for contributions.
