The School Board of Orange County, Florida (OCPS) has requested that County transfer County's interests in the Parcel to OCPS to use as part of the abutting future high school site. Public Works has reviewed and agreed to OCPS's request.

This County Deed will convey County's interest in the Parcel to OCPS. This Resolution is required by Section 125.38, Florida Statutes, as a condition precedent to this conveyance.
