The vision of the Green PLACE Program is to preserve environmentally sensitive lands that foster a community that is ecologically, economically and socially resilient.






- Initiated in 1990s

History of Admin Reg 11.07.01

- Created: 11/10/1992
- Last Revision: 6/27/2006

Key Changes Proposed in Latest Revision

- Making it clear that the regulation applies to environmentally sensitive lands (ESL) purchased with funds other than the Public Service Tax
- Deletion of the application process for new properties
- Clarifying manner in which lands offered to the County for donation will be considered
- Updating the evaluation and selection criteria for ESL acquisition

Proposed Changes to Admin Reg 11.07.01, "Environmentally Sensitive Land Acquisition"

Current Criteria

- Rarity in Orange County
- Diversity of native ecosystems
- Presence of endangered, threatened, rare or special concern species
- Contiguity with other publicly owned lands or property interests
- Manageability of the site
- Availability of funding from partners
- Likelihood of events which might degrade or destroy the site
- Amount of protection afforded by existing regulations and laws

Proposed Additional Criteria

- Provides water resource protection, aquifer recharge, or floodplain storage
- Closes gaps between other publicly-owned lands (or lands with conservation easements) or establishes or enhances an existing wildlife corridor
- Provides opportunities for quality nature-based recreation
- Opportunities to enhance ecotourism

TM/Econ Mitigation Bank Phase IV Overview

Purpose of TM/Econ

- Preservation and enhancement of ESL
- Revenue source for the purchase and management of ESL under the Green PLACE Program
- Acreage: 1,326 acres
- Mitigation Credits available for county, state, and federal permits
 - Average annual revenue generation: \$300K
 - Future revenues: ~ \$30M

Proposed New Admin Reg 11.07.02, "TM/Econ Mitigation Bank Phase IV Credits"

Summary

- Requires projects conducted by the County to purchase mitigation credits from TM/Econ Mitigation Bank Phase IV (if in the service area)
- Grants EPD Division Manager or their designee the authority to negotiate a discounted sales price per credit from the price established by the Board in order to achieve market competitiveness
