Memorandum of Agreement – Help America Vote Act Funds

The Florida Department of State and the Orange County Supervisor of Elections are to enter into a memorandum of agreement for the receipt and use of the Help America Vote Act funds for federal election cybersecurity initiatives and improvements. These funds will be used for multi-factor authentication strategies and advanced network security.

In order for the Orange County Supervisor of Elections to receive the funds of \$26,401.48, the Board needs to attest that Orange County will match the state funds with a 15% county match of \$3.960.22.

ACTION REQUESTED:

Approval and execution of Certification of County Matching Funds to Federal Grant Trust Funds under the Help America Vote Act; and approval to make a one-time payment of \$3,960.22 to the Orange County Supervisor of Elections as matching funds.
