On September 26, 2019, the Board approved an estimated budget for the Fiscal Year 2019-2020 Emergency Medical Services (EMS) County Grant in the amount of \$200,685. The Florida Department of Health awarded the grant in the amount of \$190,416, which is a decrease of \$10,269. In addition, interest of \$1,075 and a carry-over amount from the previous fiscal year of \$18,470 were awarded for a total budget of \$209,961.

Proceeds from this year's grant will be used to purchase medical and training equipment, an ambulance decontamination system, and other miscellaneous supplies and equipment. All awarded services were developed and approved by the EMS Advisory Council.
