
Zellwood Station PD / Riviera Hills Preliminary Subdivision Plan

Future Land Use Map






Zellwood Station PD / Riviera Hills Preliminary Subdivision Plan Zoning Map






Zellwood Station PD / Riviera Hills Preliminary Subdivision Plan Aerial Map









Updated Condition #24

Prior to issuance of a Certificate of Completion for this phase, if Flemings Road has not been upgraded or widened pursuant to the Village I Road Network Agreement approved by the of County Commissioners on January 28, 2020, and recorded as Document # 20200109451 in the Public Records of Orange County, Florida, then Sheet C5.10 of this PSP shall apply and that portion of Flemings Road from the subdivision entrance to the APF access road shall be reconstructed to County standards as a two-lane rural section with a minimum of twenty (20) feet pavement width and a five (5) foot sidewalk along the south side of the roadway. The APF access road, if required, shall be constructed to County standards and shall connect to Avalon Road C.R. 545. Additionally, the rural segment of the APF shall be improved to an urban section prior concurrently with any future PSP/DP within this PD that is proposed beyond Phase 4 single-family residential development, and the storm water from such urban segment shall be incorporated into a master storm water facility or an individual storm water pond at no cost to the County.
