Economic Development Incentives related to COVID-19

During this time of economic uncertainty, Orange County Government is considering temporary measures to ease the economic burden of development regulation and ensure that local business owners, developers, nonprofits and residents have the best opportunity to stay in business, create new businesses, or make necessary home improvements.

To support these objectives, the Division of Building Safety is proposing two incentive efforts relating to permitting:

1) An automatic 6-month extension of all building permits.

2) A building permit fee offset for all residential and commercial applications.

Currently, under the Governor's Executive Order 20-51, a permit holder is entitled to an extension of their permit upon notification in writing to the issuer. The proposed County program will remove the notification requirement and automatically extend each building permit issued on or before March 13, 2020, for an additional six months. All such extensions are concurrent with, and not cumulative to, any extensions obtained pursuant to the Governor's Executive Order.

The building permit fee offset program will be enabled for six months or until \$10 million is utilized. In order to provide the widest availability of opportunity, a \$100,000 cap will be instituted per project. The Division of Building Safety has determined that there are sufficient funds available in reserves for this program. No general fund dollars will be utilized for this program.

A budget transfer is necessary to provide funding for the fee offset program. The Budget Transfer Request form is attached.

Approval and execution of Resolution of the Orange County Board of County Commissioners regarding Economic Development Incentives that extends building permits and provides \$10,000,000 for building permit offsets for a six month period, and approval of budget transfer #20-1111. All Districts
