ACTION REQUESTED:

Approval to award Invitation for Bids Y20-191-MV, Staff Augmentation - Administrative, to the low responsive and responsible bidders, KeyStaff, Athena Consulting LLC. and AUE Staffing, Inc. in the total estimated contract award amount of \$10,000,000 for a three-year term. Further, request Board authorization for the Procurement Division to renew the contracts for two additional one-year terms.

PROCUREMENT:

Contracts for staff augmentation labor are used throughout the county to provide various administrative support positions such as administrative assistant, secretary, staff assistant, data entry operator, administrative support clerk, fiscal/contract administration specialist, human resources advisor, procurement specialist, senior procurement specialist, and general accounting clerk.

FUNDING:

Delivery orders will be issued on an as-needed basis.

APPROVALS:

The Procurement Division and Business Development Division concur with this recommendation.

REMARKS:

Forty bids were received in response to the Invitation for Bids and were evaluated for price reasonableness, responsiveness, and responsibility. The bids are considered reasonable based on comparison to prior similar contracts. The bids submitted by KeyStaff and Athena Consulting demonstrated a satisfactory record of performance based on validation of references. The bid submitted by AUE Staffing, Inc. has a satisfactory record of performance on current County contracts and is considered responsible. Prices for all three lowest bidders have been determined reasonable as compared to current contracted pricing.

The bids submitted by Beacon Systems, Inc. and Spartacus Consulting, Inc. were deemed non-responsible for failing to submit validating references per the bid requirements. The bid submitted by Diskriter was deemed non-responsible because the bid conflicted with the minimum pay rate requirements of the scope of services. The bids submitted by HQ Aero Management (FL), Inc., and Industrial Staffing Services, Inc. were deemed non-responsive for failing to acknowledge addendums. The bid submitted by AgreeYa Solutions, Inc. was deemed non-responsive for failing to submit a complete bid form. The bid submitted by vTech Solutions, Inc. was deemed non-responsive for failing to submit a complete bid response form and for failing to acknowledge addendums. The bid submitted by BuzzClan, LLC. was deemed non-responsive for failing to submit a complete bid package.

Three contracts are necessary due to the anticipated need for these services. The low cost contractor will be given the first opportunity to provide the required services. The other contracts will only be contacted if the low cost contractor cannot perform. Other factors such as the desire to continue the services of a contract employee who has gained experience and expertise in a certain position will be considered in the selection of the appropriate contractor.

This solicitation contains requirements for background checks and drug screens for temporary clerical personnel in certain positions prior to their performance under the resultant contracts.

Staff recommends bids be awarded to the low responsive and responsible bidders KeyStaff, Athena Consulting, LLC. and AUE Staffing, Inc.

The Business Development Division evaluated the 32 bids submitted for this project. Two of the bidders were Minority/Women Business Enterprise (M/WBE) firms and one of the bidders was a Registered Service-Disabled Veteran (SDV) firm. At the time of bid opening at least four firms were certified and at least two firms were registered at the prime level in the scope of service. The two Orange County Certified Minority/Women Business Enterprise firms and the one Registered Service-Disabled Veteran firm was not within 3% of the low bid for bid awards greater than \$5,000,000. Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
