ACTION REQUESTED:

Approval to award Invitation for Bids Y20-747-RM, Enclave Subdivision Pavement Repairs, to the low responsive and responsible bidder, Valencia Construction Group, Inc. in the total contract award amount of \$938,998.

PROCUREMENT:

Work under this contract consists of the removal and reconstruction of the subgrade utilizing a double layer of geogrid as a bridging solution to the deeper loose subgrade soil and installation of road base and asphalt. The project is located in District 2.

FUNDING:

Funding is available in account number 1004-072-2990-3816.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

Two bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Because the bid submitted by Valencia Construction Group, Inc. is approximately 28% lower than the engineer's estimate, staff held a meeting with the low bidder to confirm the scope and price. References provided were satisfactory for this type of work and Valencia Construction Group, Inc. has been determined to be responsible. Therefore, award is recommended to Valencia Construction Group, Inc.

The Business Development Division evaluated the two bids submitted for this project. One of the bidders was an Orange County certified Minority/Women Business Enterprise. The scope of services for this project had Minority/Women Business Enterprise availability. At the time of bid opening, at least 20 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, Orange County Minority/Women Business Enterprise firm Valencia Construction Group, Inc. is bidding as a prime. Therefore, Valencia Construction Group, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Valencia Construction Group, Inc. reported self-performing 100%. They reported 0% other M/WBE participation in their bid and met the M/WBE participation goal. Please note the following certified M/WBE participation:

The second low bid, submitted by Mercon Construction Company, did not achieve good faith effort documentation. While the second low bidder reported \$405,000 in M/WBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the M/WBE participation could not be confirmed. The bid was not within the M/WBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.
