## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y20-189-KB, Orange County Work Uniforms, to the low responsive and responsible bidder, Fann Emblem & Embroidery Company, Inc., in the estimated contract amount of \$1,238,729.55 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

## PROCUREMENT:

This contract will provide countywide work uniforms including shirts, pants, t-shirts, logos and embroidery.

#### **FUNDING**

## **APPROVALS:**

The Orange County Convention Center, Utilities Department, Administrative Services Department, Public Works Department, Planning, Environmental, and Development Services Department, and Business Development Division concur with this recommendation.

#### **REMARKS:**

Nine bids were received in response to the Invitation for Bids and were evaluated for price, responsiveness, and responsibility. Based on a price analysis of current unit prices the County pays for the same items under the current contract and the County's estimated cost based on these prices, the bid submitted by Fann Emblem & Embroidery Company, Inc. is considered fair and reasonable.

The bids submitted by Designlab Inc., Fann Emblem & Embroidery Company, Inc., North American Fire Equipment Co. and Promotional Designs Inc. contained a price calculation error and were corrected. GJ Embroidery was deemed non-responsive for not completing the revised bid response form.
